THE KIRINYAGA COUNTY FINANCE ACT, 2016

AN ACT of the County Assembly of Kirinyaga to amend the law relating to various taxes, charges and fees and for matters incidental thereto

ENACTED by the County Assembly of Kirinyaga as follows-

PART I-PRELIMINARY

1. This Act may be cited as the Finance Act, 2016, and shall come into operation on the first Monday of January 2017.

 - ii. deleting the words 'by the county chief officer' appearing immediately after the word designated
 - (c) by deleting the definition of 'prohibited activity'

 - iii. 'other areas' means all other areas not classified as major urban or medium urban.
