### TERMS OF REFERENCE FOR THE DESIGN, DEVELOPMENT, AND OPERATION OF COMMERCIAL CENTER AT SAGANA INDUSTRIAL CITY

#### 1. Background

The County Government of Kirinyaga has established a multi-use industrial city located within Sagana named Sagana Industrial City (SAIC). SAIC is a 242-acre climate-smart industrial city situated 101 km from Nairobi Central Business District (CBD) and centrally located in the Central Economic Region (that comprises Kirinyaga, Kiambu, Muranga, Nyeri, Nyandarua, Nakuru, Laikipia, Meru, Tharaka Nithi and Embu). SAIC is conveniently positioned along the Sagana-Nairobi dual-carriageway and Nairobi-Nanyuki railway, providing seamless access to Nairobi's airport and Mombasa's seaport. SAIC is a multi-use development that comprises (see Masterplan in figure 1):

- 1. Export Processing Zone (EPZ)
- 2. Affordable Housing
- 3. Special Economic Zone (SEZ) comprising:
  - County Aggregation and Industrial Park (CAIP)
  - Assorted Industries Zone
  - Hotel
  - Golf Course
  - Commercial Center
- 4. Supporting Infrastructure comprising:
  - Administration Center
  - Well-constructed Roads
  - Water supply
  - ICT infrastructure and mobile networks
  - Low-cost power solutions
  - Sewerage system
  - Solid Waste Management System
  - Emergency and rescue services

#### 1.1 Incentives for Investing in Sagana Industrial City

Besides Kenya providing a stable economy, wider market access through its economic and trade cooperation, and modern infrastructure, the County government of Kirinyaga has established an Export Processing Zone (EPZ) and Special Economic Zone (SEZ) at Sagana Industrial City that will provide both administrative and fiscal incentives. Additionally, the County government of Kirinyaga has set up a one-stop shop where investors are facilitated to acquire all necessary regulatory approvals such as NEMA permits and building approvals.

#### 2. Scope of the Assignment

The scope of the assignment is for the investor to design, develop, and operate a commercial center (to comprise among others, banking halls, retail shops, exhibition shops, eateries, and a supermarket) in Sagana Industrial City. The design of the commercial center will be based on the development guidelines set out for Sagana Industrial City. The County government of Kirinyaga will lease out the land for setting up the commercial center for a period of either 21, 60, or 90 years to the qualifying investor.

#### 3. Eligibility Criteria

The following are the investor eligibility criteria:

- Financially sound Kenya/International companies, proprietary/partnership firms, corporations, partnership of firms/joint ventures/consortia may apply to be allocated space at Sagana Industrial City to set up a commercial Center.
- A Group comprising of a partnership of firms, joint venture or consortium may apply to be allocated space at Sagana Industrial City to set up a commercial Center.

#### **SECTION 3: EVALUATION CRITERIA**

The Tender Processing committee appointed by the Departmental Chief officer shall evaluate the bids on the basis of their responsiveness to the Terms of Reference, applying the evaluation criteria as follows.

#### **STAGE 1: Requirements**

Bids not meeting all the mandatory requirements will receive no further consideration during the evaluation process. The Bidders shall be required to provide/meet the following.

- 1) Certificate of Incorporation
- 2) Current CR12 and any other statutory document giving details of directors
- 3) Valid Tax Compliance Certificate or its equivalent depending on the registration of the company/parent company
- 4) A business plan for the proposed activity in Sagana Industrial City
- 5) Proof of funds letter from a financial institution

NB: At this stage, the tenderer's submission will either be responsive or non-responsive.

#### APPENDIX 1 - FRAUD AND CORRUPTION

(Appendix 1 shall not be modified)

#### 1. Purpose

1.1 The Government of Kenya's Anti-Corruption and Economic Crime laws and their sanction's policies and procedures, Public Procurement and Asset Disposal Act (no. 33 of 2015) and its Regulation, and any other Kenya's Acts or Regulations related to Fraud and Corruption, and similar offences, shall apply with respect to Public Procurement Processes and Contracts that are governed by the laws of Kenya.

#### 2. Requirements

- 2.1 The Government of Kenya requires that all parties including Procuring Entities, Tenderers, (applicants/proposers), Consultants, Contractors and Suppliers; any Subcontractors, Sub-consultants, Service providers or Suppliers; any Agents (whether declared or not); and any of their Personnel, involved and engaged in procurement under Kenya's Laws and Regulation, observe the highest standard of ethics during the procurement process, selection and contract execution of all contracts, and refrain from Fraud and Corruption and fully comply with Kenya's laws and Regulations as per paragraphs 1.1 above.
- 2.2 Kenya's public procurement and asset disposal act (no. 33 of 2015) under Section 66 describes rules to be followed and actions to be taken in dealing with Corrupt, Coercive, Obstructive, Collusive or Fraudulent practices, and Conflicts of Interest in procurement including consequences for offences committed. A few of the provisions noted below highlight Kenya's policy of no tolerance for such practices and behavior:
- 1) A person to whom this Act applies shall not be involved in any corrupt, coercive, obstructive, collusive or fraudulent practice; or conflicts of interest in any procurement or as set disposal proceeding;
- 2) A person referred to under subsection (1) who contravenes the provisions of that subsection commits an offence;
- 3) Without limiting the generality of the subsection (1) and (2), the person shall be:
- a) disqualified from entering into a contract for a procurement or asset disposal proceeding; or
- b) if a contract has already been entered into with the person, the contract shall be voidable;
- 4) The voiding of a contract by the procuring entity under subsection (7) does not limit any legal remedy the procuring entity may have;
- 5) An employee or agent of the procuring entity or a member of the Board or committee of the procuring Entity who has a conflict of interest with respect to a procurement: -
- a) Shall not take part in the procurement proceedings;

- b) shall not, after a procurement contract has been entered in to, take part in any decision relating to the procurement or contract; and
- c) Shall not be a subcontract or for the tender to whom was awarded contract, or a member of the group of tenderers to whom the contract was awarded, but the subcontractor appointed shall meet all the requirements of this Act.
- 6) An employee, agent or member described in subsection (1) who refrains from doing anything prohibited under that subsection, but for that subsection, would have been within his or her duties shall disclose the conflict of interest to the procuring entity;
- 7) If a person contravenes subsection (1) with respect to a conflict of interest described in subsection (5)(a) and the contract is awarded to the person or his relative or to another person in whom one of them had a direct or indirect pecuniary interest, the contract shall be terminated, and all costs incurred by the public entity shall be made good by the awarding officer. Etc.
- 3. In compliance with Kenya's laws, regulations and policies mentioned above, the Procuring Entity:
- a) Defines broadly, for the purposes of the above provisions, the terms set forth below as follows:
- i) "corrupt practice" is the offering, giving, receiving, or soliciting, directly or indirectly, of anything of value to influence improperly the actions of another party;
- ii) "fraudulent practice" is any act or omission, including is representation, that knowingly or recklessly misleads, or attempts to mislead, a party to obtain financial or other benefit or to avoid an obligation;
- "collusive practice "is an arrangement between two or more parties designed to achieve an improper purpose, including to influence improperly the actions of another party; "coercive practice" is impairing or harming, or threatening to impair or harm, directly or indirectly, any party or the property of the party to influence improperly the actions of a party; iv) "obstructive practice" is:
- Deliberately destroying, falsifying, altering, or concealing of evidence material to the investigation or making false statements to investigators in order to materially impede investigation by Public Procurement Regulatory Authority (PPRA) or any other appropriate authority appointed by Government of Kenya into allegations of a corrupt, fraudulent, coercive, or collusive practice; and/or threatening, harassing, or intimidating any party to prevent it from disclosing its knowledge of matters relevant to the investigation or from pursuing the investigation; or
- Acts intended to materially impede the exercise of the PPRA's, or the appointed authority's inspection and audit rights provided for under paragraph 2.3 e. below.
- b) Defines more specifically, in accordance with the above procurement Act provisions set forth for fraudulent and collusive practices as follows:

"fraudulent practice" includes a misrepresentation of fact in order to influence a procurement or disposal processor the exercise of a contract to the detriment of the procuring entity or the tenderer or the contractor, and includes collusive practices amongst tenderers prior to or after tender submission designed to establish tender prices at artificial non-competitive levels and to deprive the procuring entity of the benefits of free and open competition.

- c) Rejects a proposal for award<sup>1</sup> of a contract if PPRA determines that the firm or individual recommended for award, any of its personnel, or its agents, or its subconsultants, subcontractors, service providers, suppliers and/ or their employees, has, directly or indirectly, engaged in corrupt, fraudulent, collusive, coercive, or obstructive practices in competing for the contract in question;
- d) Pursuant to the Kenya's above stated Acts and Regulations, may recommend to appropriate authority (ies) for sanctioning and debarment of a firm or individual, as applicable under the Acts and Regulations.
- e) Requires that a clause be included in Tender documents and Request for Proposal documents requiring(i) Tenderers (applicants/proposers), Consultants, Contractors, and Suppliers, and their Sub-contractors, Sub- consultants, Service providers, Suppliers, Agents personnel, permit the PPRA or any other appropriate authority appointed by Government of Kenya to inspect<sup>2</sup> all accounts, records and other documents relating to the procurement process, selection and/or contract execution, and to have them audited by auditors appointed by the PPRA, or any other appropriate authority appointed by Government of Kenya; and
- f) Pursuant to Section 62 of the above Act, requires Applicants/Tenderers to submit along with their Applications/Tenders/Proposals a "Self-Declaration Form" as included in the procurement document declaring that they and all parties involved in the procurement process and contract execution have not engaged/will not engage in any corrupt or fraudulent practices.

For the avoidance of doubt, a parties in eligibility to be awarded a contract shall include, without limitation, (i) applying for pre-qualification, expressing interest in a consultancy, and tendering, either directly or as a nominated sub-contractor, nominated consultant, nominated manufacturer or supplier, or nominated service provider, in respect of such contract, and (ii) entering into an addendum or amendment introducing a material modification to any existing contract.

<sup>2</sup> Inspections in this context usually are investigative (i.e., forensic) in nature. They involve fact- finding activities undertaken by the Investigating Authority or persons appointed by the Procuring Entity to address specific matters related to investigations/audits, such has evaluated the veracity of an allegation of possible Fraud and Corruption, through the appropriate mechanisms. Such activity includes but is not limited to: accessing and examining a firm's or individual's financial records and information, and making copies thereof as relevant; accessing and examining any other documents, data and information (whether in hard copy or electronic format) deemed relevant for the investigation/audit, and making copies there of as relevant; interviewing staff and other relevant individuals; performing physical inspections and site visits; and obtaining third party verification of information
