#### 1. INTRODUCTION

Kirinyaga County is a leading producer of agricultural raw produce and presents an ideal opportunity for agro-processing and related activities. In line with the Bottom-Up Economic Transformation Agenda (BETA), the County Government of Kirinyaga is establishing an industrial city to drive its manufacturing sector. The multi-use industrial city is located within the Sagana, Ndia sub-county, and includes an Export Processing Zone (EPZ), Affordable Housing, and a Special Economic Zone (SEZ). The SEZ comprises of County Aggregation and Industrial Park (CAIP), an assorted industries Zone, a hotel, and a Commercial Center. Additionally, the city will have supporting Infrastructure, including an Administration Center, well-constructed Roads, Water supply, Low-cost Power solutions, a sewage system, and a Solid Waste Management System.
