MIN. 1/MUN/SEC/8/10/24: Preliminaries

The meeting commenced at 9:45 a.m., with quorum established by the board chair. Milka Chomba led the opening prayers. Afterward, members self introduced themselves.

MIN. 2/MUN/SEC/8/10/24: Development Control Bill and Regulation.

The deliberation session on the stated Development Control tools was led by the County Director of Planning, who provided an extensive overview of the development control process, the bill and regulations. Key points discussed were as follows:

1. Introduction

The Director outlined the importance of development control in ensuring sustainable and orderly urban growth in accordance with set regulations.

2. Definition of Development Control

Development control was defined as the process of regulating land use, building standards, and urban development according to approved physical development plans and policies. Its core objective is to promote organized growth and environmental protection.

3. Legal Framework

The key legislation governing development control in Kenya includes:

- The Physical and Land Use Planning Act, 2019
- The Environmental Management and Coordination Act (EMCA), 1999
- County government by-laws

The responsibility for enforcement rests with planning authorities, particularly county governments.

4. Development Application Process

The Director outlined the steps required for submitting development applications to county governments or planning authorities. These include:

- Submission of building plans
- · Land subdivision requests
- Environmental impact assessments (EIA), where applicable

Authorities review these proposals based on zoning laws, public interest, and environmental considerations.

5. Role of County Governments

Kirinyaga County is responsible for regulating and approving developments within its jurisdiction. Collaboration with developers and other stakeholders is essential to ensuring compliance with both county and national regulations.



6. Challenges in Development Control

The Director noted several challenges faced in development control, including:

- Limited enforcement capacity due to insufficient staff and resources
- Prevalence of illegal developments and land encroachments
- Public ignorance regarding planning regulations

7. Public Participation

Public involvement in development control was emphasized as a constitutional requirement under Kenyan law. The public is encouraged to engage in planning processes to promote transparency and accountability.

8. Innovations in Development Control

Innovative tools such as Geographic Information Systems (GIS) are now being used for land use mapping and monitoring. Additionally, digital platforms have been introduced for the submission and tracking of development applications.

9. Way Forward

The Director proposed several measures to improve development control processes, including:

- Strengthening enforcement mechanisms and building the capacity of county and municipal officials
- Enhancing public awareness of development regulations
- Improving collaboration with national agencies to streamline approval processes

10. Conclusion

The Director concluded by underscoring the importance of development control in fostering sustainable, inclusive urban growth within Kirinyaga County. He urged continued stakeholder



consultations, monitoring of ongoing projects to ensure compliance, and capacity building for planning officers.

Responses from Participants:

Anthony Mugo, Ward Administrator for Kerugoya, suggested that the building inspection process should be simplified for the general public, many of whom lack technical knowledge about development procedures.

Edward Gatitu, Ward Administrator for Nyangati, raised concerns about encroachments on access roads in Kutus Mjini, which are hindering movement in the area.

Members noted the ramphath encrouchment of the public streets, access rural and urban roads and public galleries within the municipality.
