

1. Submission.

Interested and eligible candidates may obtain detailed information and inspect the tender documents at Kirinyaga County Headquarters, Kutus, Supply Chain Management Office, Room **B13** during normal working hours. Interested and eligible tenderers may obtain further information from and inspect the tender documents at Director Supply Chain Management Services Office, 1st Floor, Kirinyaga County Headquarters, Kutus during normal working hours.

A complete set of tender documents may be obtained by interested and eligible bidders from the Public Procurement Information Portal website <http://tenders.go.ke> or the County website www.kirinyaga.go.ke. Bidders who download the documents from the website **MUST** forward their particulars (Name, contacts, physical address, and the tender No./ description) immediately to procurement@kirinyaga.go.ke for recording and any further clarifications or addendums.



Prices quoted should be inclusive of all taxes and delivery costs and must be expressed in Kenya shillings and shall remain valid for a period of 180 days from the closing date of the tender.

Tender **MUST** be accompanied by an original bid security for the amount indicated in the tender document issued in Kenya shillings or a freely convertible currency and in the form of bank guarantee, or an insurance guarantee from PPRA Approved Insurance Company in the format provided valid for an additional 30 days beyond the tender validity period from the date of tender opening.

2. Bid Security Submission Requirements

Bidders shall provide a tender security of **Kenya Shillings One Million (KES 1,000,000.00)** in any of the following forms: **a bank guarantee; a guarantee by an insurance company registered and licensed by the Insurance Regulatory Authority listed by the Authority** of not less than the specified amount, or its equivalent in a freely convertible currency. The original bid security/bid bond—whether in physical form or a digitally generated bond—must be submitted to the County Government of Kirinyaga, Supply Chain Management Office, Room B13, County Headquarters, Kutus, during normal working hours and no later than the tender closing date and time indicated above.

The bid security shall be enclosed in a sealed envelope clearly marked with the tender description and addressed as specified in the tender document.

Important: Failure to submit the **original physical bid security** or the **digitally generated bid security** by the tender closing date and time shall result in automatic disqualification of the bid.


